- We guarantee that we will represent a good example and contribute to improving open government in other countries by sharing best practices and know-how and voluntarily implement responsibilities set out in the Declaration. Our goal is to initiate innovation and fast progress and not to determine standards as preconditions for cooperation, assistance or ranking countries. We emphasize the importance of promoting transparency and overall approach as well as technical assistance to support capacity development and institution building.
- We commit ourselves to adopt these principles in relation to our international engagement and foster a global culture of open government that empowers citizens and advances the ideals of open 21st century government.
